Terms and Conditions relating to Tradestands

Traders should read this in conjunction with Bedwellty Agricultural Society's Health and Safety Policy which is available at http://www.bedwelltyshow.co.uk/health-safety-policy/.

A completed Risk Assessment should be returned with the 'Tradestand Application Form'. We reserve the right to request additional information where the Society believes further mitigation measures are required.

The Society may refuse any Application and revoke any previously accepted application entirely at their discretion.

The Society will only deem the application to be valid where the forms are properly completed and the risk assessments are returned concurrently. The Society does not allow the sub letting of pitches. The Applicant should be the same entity, person(s) or company that is the occupier of the pitch on Show day. A pitch is the area that is assigned or allocated by the Society to the

The Society does not provide any warranties as to the suitability or profitability of the pitch. The land to which the Trader is allocated may be uneven ,sloping, shaded or unshaded. Please remember the agricultural setting.

There is no mains water or mains electricity available to Traders and their pitches. Generators would ideally be of the run silent or baffled/quieter type. Petrol and Diesel handling and storage should therefore be included in any Risk Assessment. Fuels should be stored in upright watertight containers. It is not acceptable for containers or generators to leak profusely onto the ground.

Layout — Please ensure that you allow for a sufficient area not only for your stand but also to accommodate any guy ropes, parking for any vehicles, stock storage or similar. Guy Ropes, awnings, vehicles (and tow bars) should not over sail or encroach on neighboring pitches. Your pitch must not impede, obstruct or interfere with any adjoining pitches.

If you have flags, TV Screens or Sound Systems we may ask you to use them in such a way as to prevent the startling of livestock, for example. Traders will not promote goods in a manner that is overly aggressive or that overwhelms our own Public Announcements. Goods are not to be sold by Auction. If you have a Stand that features any of the above please confirm the nature of promotion to us by contacting the Secretary.

You are responsible for ensuring that any waste or rubbish is removed from site and disposed of properly. The leaving of waste may result in you being refused access to the show in the future. We ask that you leave the area clean and tidy. We are not on land owned by ourselves.

You may only use vehicles during the setting and dismantling stages of the show. You may not use vehicles on the Showground on Show day unless complying with the directions of any Steward. A Site Speed Limit will be in effect and you should keep vehicles movements on the Showground to a minimum.

Traders confirm that they have in place all necessary Insurances for their associated activity. This includes adequate cover relating to Employers Liability, Public Liability, Product Liability and to keep the Society fully indemnified of any costs claims or actions. Evidence of insurance cover must be provided at time of booking. Any stalls selling food must provide evidence of food hygiene certificates at time of booking.

We ask you to refrain from releasing Balloons, Fireworks, Smoke and Water as part of any display without prior consent.

If a booking is cancelled by the Society (which includes the show being cancelled for any reason) the compensation or reinstatement is limited to an amount equal to the amount paid for the Tradestand pitch less 10% to cover any cost the Society has incurred in reviewing, receiving or processing any application. If a Trader is to cancel an Application please contact the Secretary. The Society will issue a refund up to 28 days before the Show. The Society may again retain 10% of any refund amount to cover and costs in reviewing receiving or processing the withdrawn application.

The Society considers that upon being paid the relevant fee for any Tradestand Pitch the terms detailed above are accepted and understood by the applicant.
